SB191	Curtis VanderWall (R), The bill would amend PA 258 entitled "Mental Health Code" to expand the definition of "mental health professional" to include a physician assistant, a certified nurse practitioner, and a clinical nurse specialist-certified as well allow certain physical examinations to be conducted by a physician assistant, a certified nurse practitioner, or a clinical nurse specialist-certified.	2/25/21 submitted and referred to committee on Health Policy and Human Services. 4/20/21 reported favorably with amendment and back to Committee of the Whole in the Senate 4/29/21 <b>Senate passed bill</b> and sent over House and they referred to Health Policy committee			
SB166	Curtis VanderWall (R), The bill would amend PA 258 entitled "Mental Health Code" to expand the allow a pharmacist to dispense a drug or device pursuant to a prescription transmitted by an advanced practice registered nurse prescriber or physician's assistant prescriber in another state or province of Canada without determining whether the advanced practice registered nurse prescriber or physician's assistant prescriber was authorized under the laws of the other state or province of Canada to issue the prescription under certain circumstances. HB4482	Yousef Rahbi (D), [and 49 other sponsors] Requiring Hospitals to Develop a Nurse Staffing Plan. A bill to amend 1978 PA 368, entitled "Public health code," (MCL 333.1101 to 333.25211) by adding section 21525. Details of expected nurse to patient staffing ratios in specialty and defined nursing units in hospital settings to be in effect at all times including breaks, meals and other routine absences.	3/9/21 referred to Committee on Health Policy			MONL has a White Paper describing points of opposition to this legislation

HB4483	Sara Cambensy (D), Prohibit Mandatory Overtime for Nurses. A bill to amend 1978 PA 368, entitled "Public health code," by amending section 20165 (MCL 333.20165), as amended by 2008 PA 39, and by adding sections 17233 and 21526. Specifically points out that a refusal to work more than scheduled predetermined work schedule is not by itself grounds for administrative action. The hospital could not discharge or discipline, threaten to discharge or discipline, or otherwise discriminate against an employed registered nurse for refusing to work additional non-scheduled hours.	3/9/21 referred to Committee on Health Policy			MONL has a White Paper describing points of opposition to this legislation

HB4484	Roger Hauck (D), Require Hospitals to Maintain Full Record of Nurse-to-Patient Ratios. A bill to amend 1978 PA 368, entitled "Public health code," (MCL 333.1101 to 333.25211) by adding section 21525a. Legislation that dictates each hospital keep accurate records of nurse-to-patient ratio assignments in each nursing unit for not less than three years. The record must include the number of patients in each unit and the identity and duty hours of each direct care registered nurse assigned to each patient in each unit for each shift.	3/9/21 referred to Committee on Health Policy			MONL has a White Paper describing points of opposition to this legislation

HB4359	Mary Whiteford (R), A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 17210 and 17708. Allowing addition to duties within a CRNA's scope of practice including anesthesia and analgesia services in developing a plan of care, and performing all patient assessments, procedures, and monitoring to implement the plan of care or to address patient emergencies that arise. An employer shall not discharge, fail or refuse to hire or discriminate against a qualified individual with respect to employment because the individual has not received or declines to receive, for any reason a specified vaccination (including influenza, COVID-19, tetanus, diphtheria, and pertussis vaccinations)	3/9/2021 Submitted to two committees: Commerce Tourism 3/23/21 to Workforce, Trades and talent.				
HB4667	Sue Allor (R), "COVID-19 vaccination privacy act" A bill to prohibit producing, issuing, or providing an incentive for COVID-19 vaccination passports. SB680	Rick Outman (R)[w/ bi-partisan co-sponsors] , A bill to amend 1978 PA 368, entitled Public health code. It outlines the requirements that an individual needs to successfully complete to achieve nurse practitioner status in the State of Michigan. It would allow a nurse practitioner to practice at the top of his or her scope of practice including prescribing a controlled substance included in schedules two to five of part 72 of the public health code without delegation from a physician.	10/6/21 submitted and referred to committee on Health Policy and Human Services.				

HB5556	John Roth (R) A bill to amend 1966 PA 331, entitled "Community college act of 1966," by amending section 121(MCL 389.121) granting of bachelor of science degrees in nursing. HB5557 Tie-bar to 5556	John Dmoose (R) A bill to amend 1966 PA 331, entitled "Community college act of 1966," by amending section MCL 389.105. House Bill 5557 is a companion bill that would amend the definition of community college to provide that a qualifying institution could offer a BSN. HB5084	Ben Frederick (R) A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 81d (MCL 750.81d), as amended by 2006 PA 517. It states that if someone assaults, batters, wounds, resists, obstructs, opposes, or endangers a person who the individual knows or has reason to know is performing his or her duties in an emergency room, operating room, or trauma center of a hospital will be charged with a felony and various consequences to level of assault.	6/22/21 referred to Committee on Government Operations			This legislation would bring Michigan in line with 32 other states where it is a felony to assault healthcare workers or emergency medical personnel. The MHA potential amendments to expand the legislation to protect healthcare workers in all care settings and will continue to monitor the legislation. There are three other states that have current bills introduced this year.	
HB5682	Mike Mueller (R) A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending sections 81, 81a, and 82 (MCL 750.81, 50.81a, and 750.82), section 81 as amended by 2016 PA 87, section 81a as amended by 2012 PA 366, and section 82 as amended by 1994 PA 158. HB6364	Sarah Lightner (R) A bill to amend 1978 PA 368, entitled "Public health code," by amending sections 20106, 20109, and 20161 and other detailed sections including a provision to ensure supplemental nursing service agencies cannot prohibit their employees from being hired full-time by health facilities where they may be working, or be required to otherwise pay fees to be hired full-time by those facilities. In addition, the rates charged by supplemental nursing service agencies would not be able to exceed 25% of the hourly wage paid to a nurse, nursing assistant, nurse aide or orderly currently employed by the health facility saving exorbitant contract labor expenses that threaten the financial sustainability of hospitals	9/7/2022 referred to Health Policy Committee
